From Holsworthy, proceed on the A3072 Bude road and on the edge of town, opposite the BP Garage, turn right signed Bradworthy/Chilsworthy. Follow this road for some 7 miles until you reach the village square in the centre Bradworthy. Park in the expansive village square and then from here, walk down the entrance to the right of "Penbode Vets" where Eastways Cottage will be found on the right hand side of the courtyard.
