From our Bude office turn right towards the end of Queen Street and then left into Princes Street towards the Post Office. Upon reaching Belle Vue take the right hand turning along Morwenna Terrace whereupon Erdiston Court will be found within approximately 150 yards on the left hand side. The entrance to number 11 is to the rear of the property and flat 11 is located on the first floor.

Rental Terms - The rent for the property is £900 per calendar month exclusive of all other outgoings and payable monthly in advance.

The property will be let on a twelve month assured shorthold tenancy. In addition to the first months rent a deposit of £1038 will be required.

The property will be available immediately.

A verifiable household income of at least £27,000 per annum is required to be considered.
