



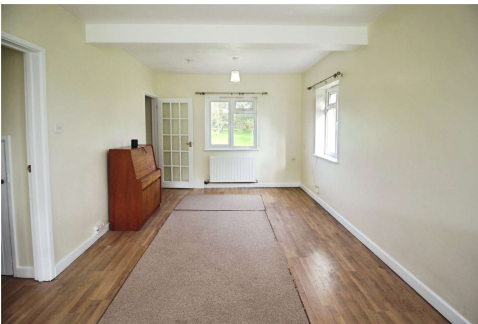

From Holsworthy proceed on the A3072 Bude road and upon reaching the edge of Holsworthy, opposite Bude Road Garage, turn right signed Bradworthy/Chilsworthy. Follow this road for approximately 1 mile and take the left hand turning onto an unsigned road (if you reach the village of Chilsworthy you've gone too far). Follow this road for a short while and turn right onto a driveway which has a Public Footpath sign. Follow the driveway and Parnacott Farm Annexe will be found at the end of this lane.
