From Bude town centre proceed out of the town towards the A39, at Bude service station turn right to Kings Hill, proceed until reaching the A39 and turn right signposted Camelford and follow this road for 9.5 miles. After the 9.5 miles turn right onto the Boscastle road (B3263) and after 1.5 miles turn right, signposted Crackington Haven. Follow this road for 1 mile and the property will be found on the left hand side down a lane.
