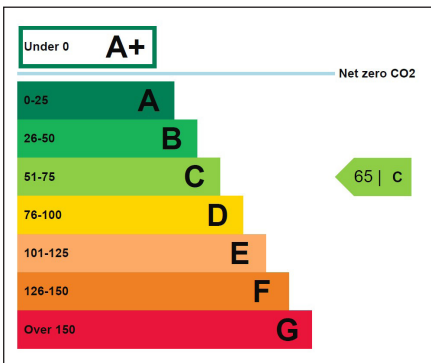

Location

Bangor is a large coastal town and tourist resort in the heart of Co Down located approximately 12 miles (19 km) from Belfast.

The property occupies a prime location on Main Street close to its junction with Castle Street. Neighbouring occupiers include Bank of Ireland, Boots, Nationwide Building Society and Greggs.

Description

This is a substantial two storey mid terrace commercial building of traditional construction covered with a flat roof. The property benefits from a service entrance to the rear via Bingham Lane.

Internally the ground floor is finished with an open plan finish with a staircase to the first floor. To the rear is a service area which includes a gas boiler and 1,100 kg lift. Access to the rear yard is via double doors. Finishes include suspended ceilings and fluorescent lighting. The first floor is again laid out on an open plan basis with a similar finish, there is a small mezzanine area above. The building is secured by an electric roller shutter.
