Floorplan

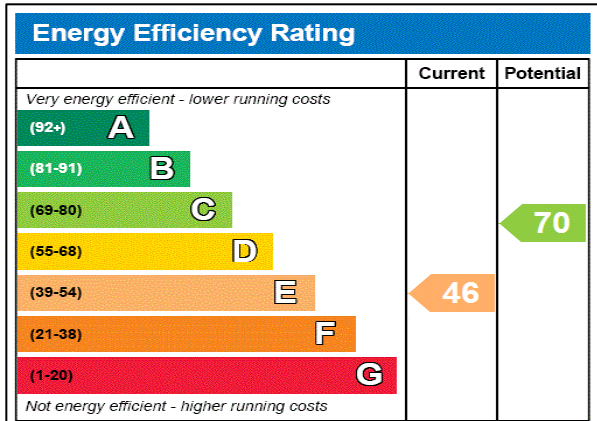


Floor 1

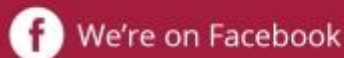
