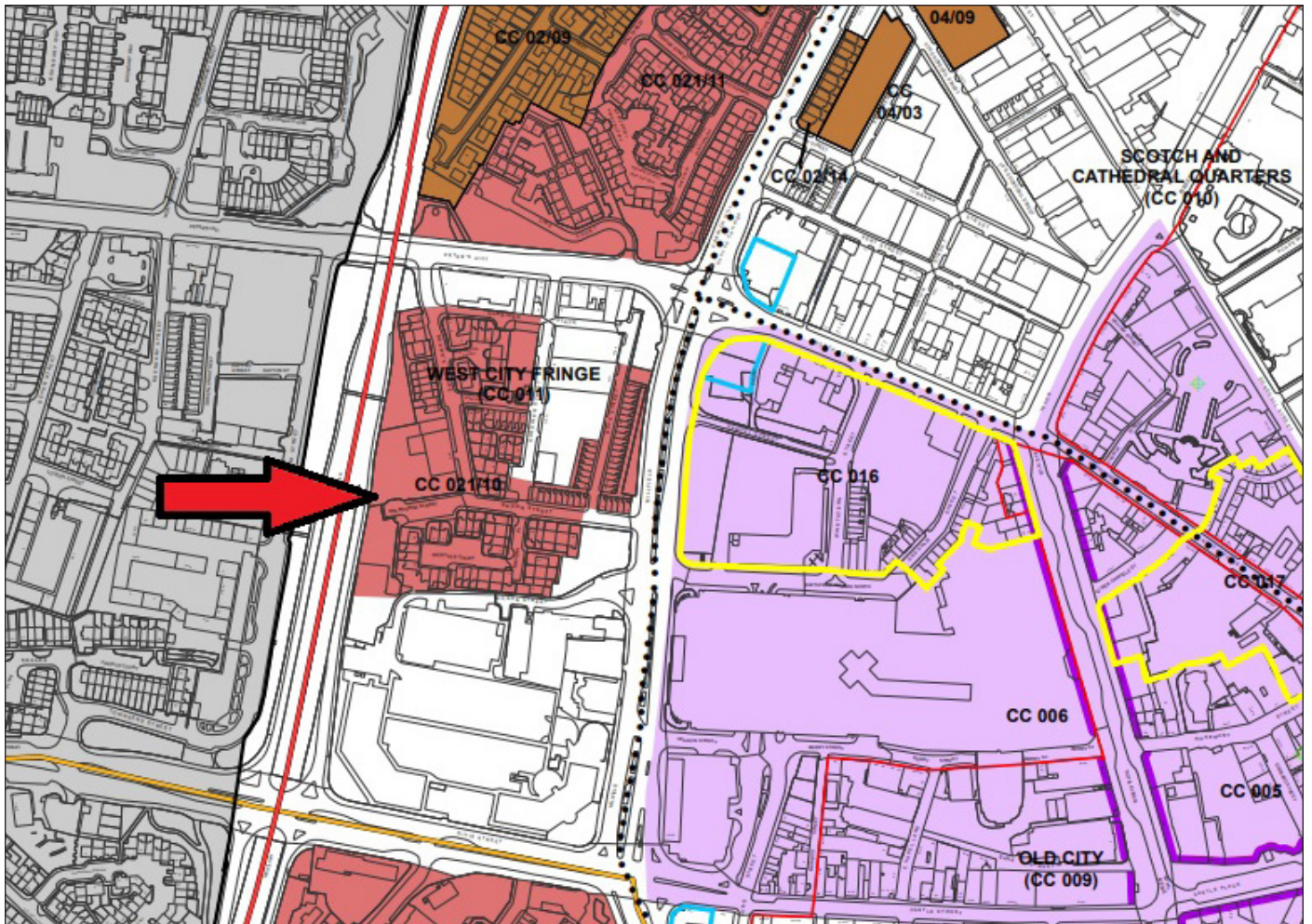

Under BMAP 2015 the site is zoned as Protected City Centre Housing Area.





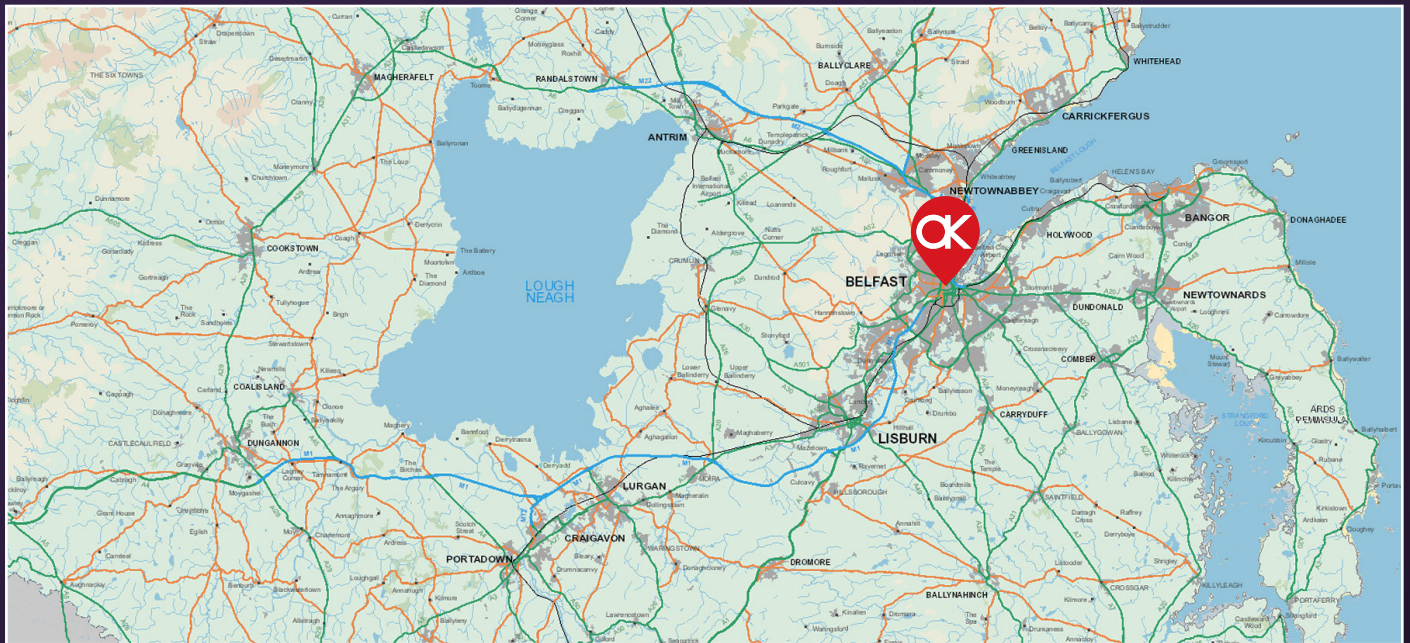
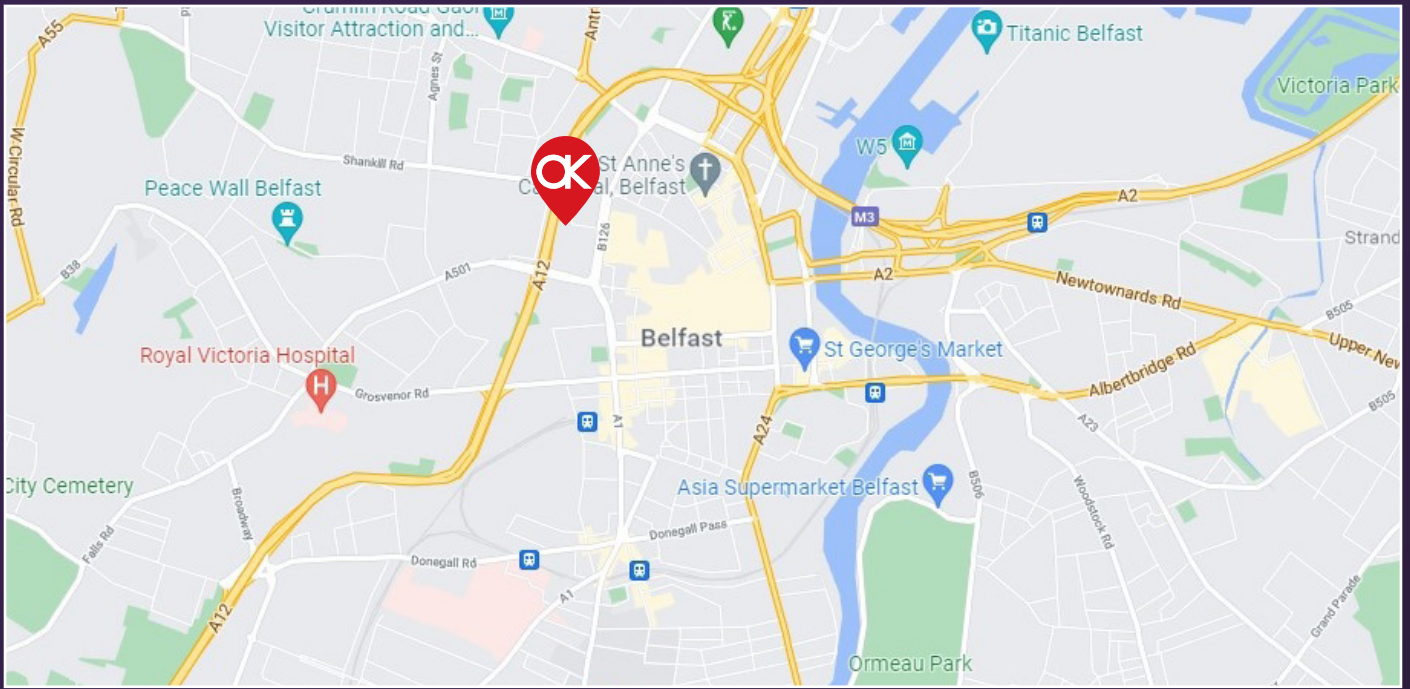
Zoning Map
