

SUMMARY

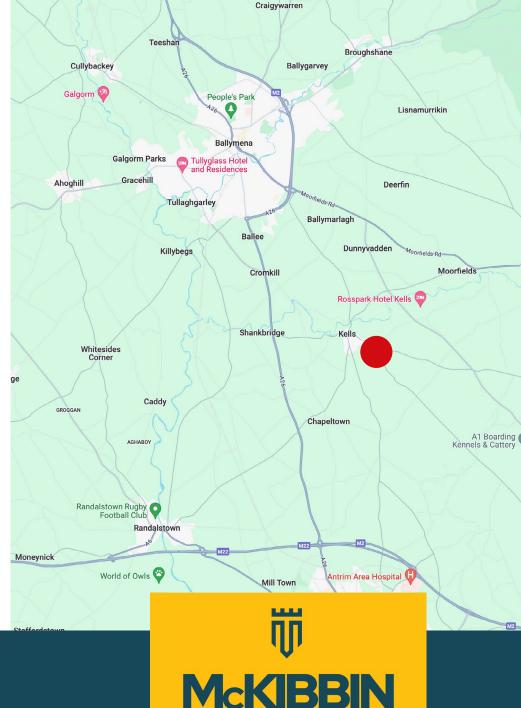
- The site comprises c. 12.4 acres and is located off Parkgate Road, Kells
- Sits within close proximity to Ballymena and the A26.

LOCATION

- The subject is located off the Parkgate Road, as well as to the rear of Rossburn Manor / Carncome Road. Road Roundabout. It is approximately 5.7 miles from Ballymena and 3.2 miles to the A26.
- The surrounding land use principally comprises residential dwellings, as well as agricultural land and farms.

DESCRIPTION

 The plot is split into five separate folios and comprises of c. 12.39 acres of agricultural land. To the North is a mixture of agricultural land and a residential development and to the south boundary runs runs the Braid River / Parkgate Road as well as further residential dwellings. Access is from a laneway between numbers 38&40 Parkgate Road via bridge.

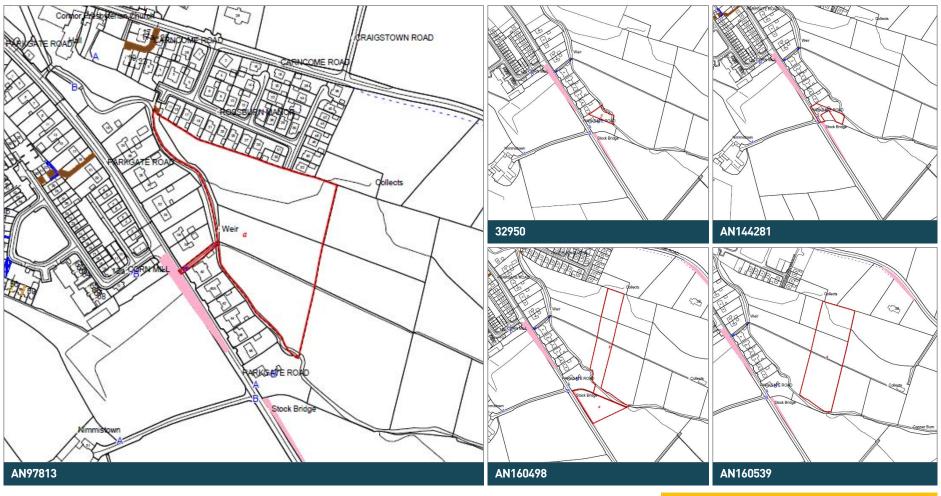
