Consideration may be given to letting the car park on a space-by-space basis.

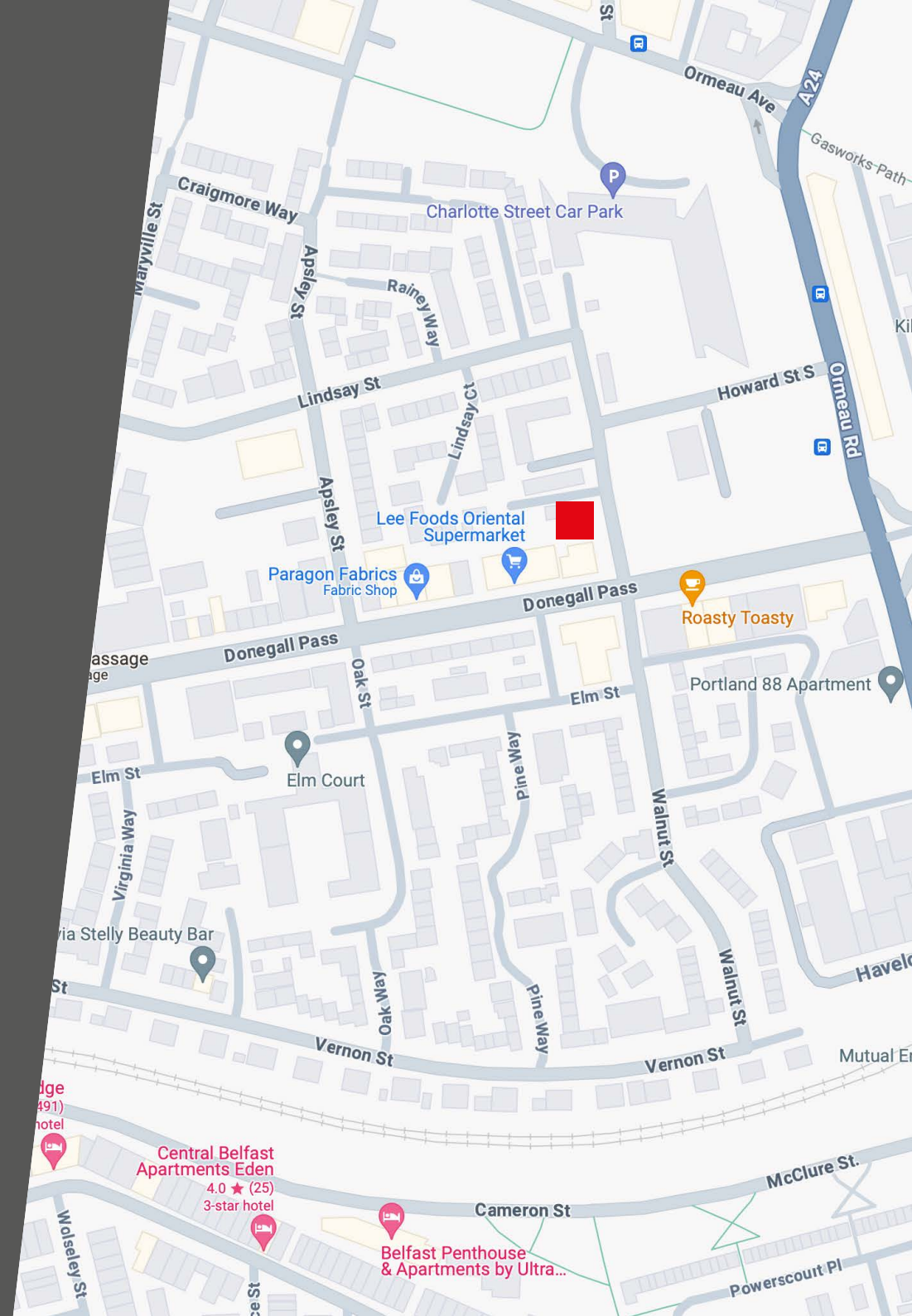
