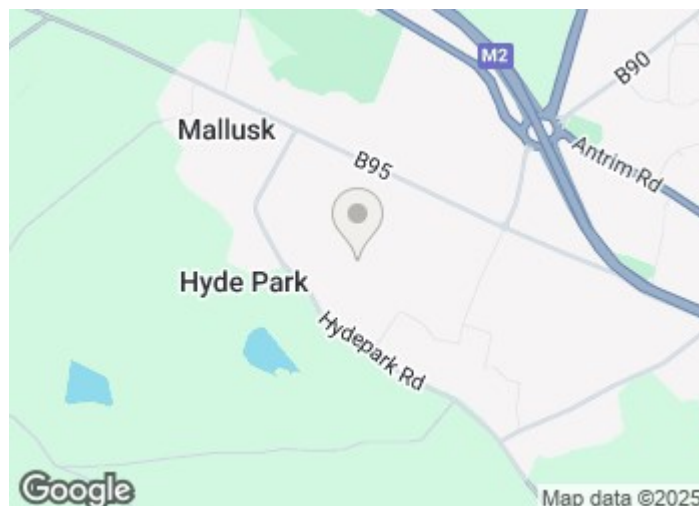

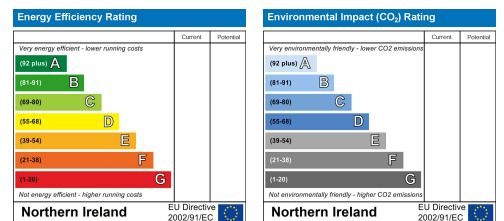


Directions
