#### Location

Ballyclare is a popular commuter town given its close proximity to the motorway network providing easy access to Belfast and other parts of NI. Ballyclare is c. 13 miles north of Belfast, 11miles from Antrim and 15 miles from Ballymena.

More specifically the subject property is located just outside Ballynure on Church Road, within a small industrial estate. The area benefits from a rural location whilst also being very accessible, situated just 1 mile from access to the A8 and 7 miles from Sandyknowes roundabout providing access on to the M2.
